AS THE PRIMARY CONTACT FOR A TRAINING COMPANY CONFIRMED TO USE THE ABOVE LISTED PPC RANGE BAY FOR THE SPECIFIED TIME AND DATE, I AGREE TO THE FOLLOWING:

- 1. I have read and understand all PPC Rules, Procedures, and the User Group agreement and will abide by all listed requirements.
- 2. I will require that all students know and follow the PPC rules and procedures.
- 3. I will not allow anyone to attend or audit a class outside the students listed in the class roster without express permission by the range manager, administrator, program director, or the on duty PPC Range Safety Officer.
- 4. I will not conduct a class if I have not confirmed that my instructor liability insurance is valid for the date, time, and type of class being held.
- 5. I will ensure that before any class content is presented, the Student Roster and Range Waiver packet is fully completed and signed by all attending students and does not exceed the total number of students listed for the confirmed range bay or time of class.
- 6. Before any live fire set up or activities, I will have a user group course instructor outline and communicate an Emergency Action Plan to all attending students and provide my own first aid and emergency kits for the class.
- 7. I acknowledge that I have become familiar with any general range procedures and specific range bay rules and I will control the class in keeping with these rules and procedures.
- 8. I acknowledge that I am fully responsible for the actions and safety of the students, instructors, and their impact on other range members & guests.
- 9. I am responsible for the clean up of the confirmed range bay and I will leave it in an orderly state when the class is completed.
- 10. I will schedule activities so that the range is clean and that students are off the bay at the scheduled time and I will be the last person to leave the bay when the class is completed.
- 11. I will require eye and ear protection for all range users.
- 12. Before instruction begins, on the day of the class, I will provide the completed Student Roster packet and completed Range Waiver forms to the on duty RSO and I agree to settle listed range fees in a timely manner as directed by the on site PPC RSO or on site PPC staff member after the completion of the course.
